Please read the following information regarding Membership at Jericho Tennis Club and indicate your understanding and agreement of the guidelines and requirements of Membership by signing at the bottom. This Application Declaration must be returned with your Membership Application Form.

- a. The information I/we have provided is true and accurate.
- b. I/we have read the application form and appendices and fully understand the material, including the Club's Membership Categories and Wait List Policies and Procedures.
- c. If my/our application is accepted, I/we here by agree to abide by the Bylaws and Rules passed by Jericho Tennis Club at any time I/we am a Member thereof, and to pay all dues, fees and assessments set by the Jericho Tennis Club.
- d. I/we understand that Jericho Tennis Club is an adult oriented Club that has restrictions on the hours and areas of use of the entire facility for all individuals under the age of 17.
- e. I/we understand and agree that the deposit fee once cashed, and the entrance fee is non-refundable and non-transferable in whole or in part.
- f. I/we understand that the admission of new Members from the Applicant Wait List is prioritized on a preferred basis for applicants applying for Full Play or Squash memberships and will be prioritized over Social 2 memberships.
- g. I/we understand that related applicants are spouses of existing Members and children of existing Members under the age of 32.
- h. I/we understand and agree that the total entrance fee payable shall be the entrance fee rate in effect at the time are placed on the waitlist.
- i. I/we understand and agree that how the entrance fee is paid out will be determined by the age of the applicant at the time a Membership position is offered.
- j. I/we understand and agree that for Social and Full Play application that once I/we accept a Membership position, I/we are required to pay the outstanding balance of the entrance fee owing.
